## Children's Services Council 1<sup>st</sup> Public Budget Hearing 2018-2019 Minutes September 13, 2018

Melisa Jahner called the Children's Services Council's 1<sup>st</sup> Public Budget Hearing to order at 5:10 p.m., at the Okeechobee County School Board, 700 S.W. 2<sup>nd</sup> Avenue, Room 303, with the following members present: Pat McCoy, Melisa Jahner, Vern Melvin, Heather Hancock, Wendy Coker, Judge Bryant and Cathleen Blair, Executive Director

Cathleen Blair presented a millage rate of .4000 which is 6.2% greater than the rollback rate of .3766 with 95% collection. Vern Melvin made a motion to approve the millage rate of .4000 with a 95% collection for 2018-2019, Wendy Coker seconded, all approved.

Cathleen Blair presented the following Tentative Budget using the millage rate of .4000 for 2018-2019. Using 95% collection of Taxable values, the projected ad valorem revenue is \$732,449 and an estimated Interest Income of \$1,000.00 and a Fiscal Year Beginning Fund Balance of \$195,935 with all the projected expenses totaling \$803,571.

Cathleen Blair presented a request from Lexi Ward, Scholarship recipient. Lexi has completed her Bachelor degree and now pursuing her Masters in Speech Pathologist. A discussion was held if she had received all of funds for 4 years in the amount of \$2,000 per year. It was noted that Lexi had only received her scholarship funding for 3 years. Also, a discussion was held if paid for graduate school and what the Council set up as requirements. Cathleen Blair stated she would need to pull the requirements. Pat McCoy made a motion to table this request until the next meeting.
