TRIM Guideline 2023-2024

Step 1: July 1, 2023

Step 2: Within 15 days of 7/15 – adopt Tentative Budget/Approved Millage, Date/Time/Place of Budget

Hearing.

July 13, 2023 (Thursday - Regular Meeting)

Step 3: Prior to August 4, 2023 (within 35 days of certification)

Return DR-420

CSC - Advice Property Appraiser

Prior Year Millage Rates Current year rolled back rate

Date, time and meeting place of Tentative Budget Hearing

Step 4: 1st Public Hearing – Tentative Budget

(No sooner than September 3 - no later than September 18)

Possible Dates: September 5, 2023 (Tuesday)

September 14, 2023 (Thursday - Regular Meeting)

Step 5: Advertisement of Final Budget Hearing:

Possible Dates: September 13, 2023 (Wednesday) if meeting is September 15, 2023

(Friday) or September 18, 2023 (Monday)

September 20, 2023 (Wednesday), if meeting is September 22, 2023

Must hold Final Public Hearing no sooner than 2 days or later than 5 days after advertisement.

Step 6: Final Budget Hearing

If advertised on September 13, 2023 (Wednesday) - Hearing would have to be September 15,

2023 (Friday) or September 18, 2023 (Monday)

If advertised on September 20, 2023 (Wednesday) - Hearing would have to be September 22,

2023 (Friday) or September 25, 2023 (Monday).

Step 7: Within 3 days – forward Resolution, Ordinance and final millage to Property Appraiser and Tax

Collector

Step 8: Within 3 days receiving Final Taxable Value - Complete DR-422 and send to Property Appraiser.

Step 9: No later than 30 days - Certify Compliance Form DR-487 to Department of Revenue.
