The Guardians for the New Futures-Stephanie Castelan, addressed the Council, spoke about the summer program with the County. Kristy then indicated there were over 200 children that were abused or neglected in Circuit 19 this year, and the Advocacy Center-housed in Port St. Lucie saw the children at the Center with all personnel involved in the case in attendance. Pat Mc Coy asked what curriculum they used with the children. She indicated it was a researched program called LDL.
