MINUTES

April 23, 2024

In attendance for the meeting were Melisa Jahner-Chairperson, Wendy Coker, Bob McPartlan, Heather Hancock, Frank DeCarlo, Dylan Tedders, Pat McCoy, William Wallace and Toni Wiersma-Executive Director.

Meeting called to order by chairman Melisa Jahner at 5:04 PM

- a) Additions or corrections to the agenda
 - (1) Melisa Jahner added item 10a Executive Director Salary

Wendy Coker made the motion to accept additions. Dylan Tedders seconded the motion. The motion carried.

2) Approval of Minutes:

a) Meeting – March 21, 2024. Bob McPartlan made a motion to approve the minutes. Wendy Coker seconded the motion. The motion carried.

3) Approval of Financial Statements:

Toni Wiersma also presented the Management Report for the Fiscal Year 2023-2024 and the Profit and Loss statement for the period October 1, 2023 – March 31, 2024. Mrs. Wiersma pointed out to the Board the categories listed on the Profit and Loss Statement

b) Toni Wiersma also presented the actual budget vs. the amount spent in each category. Our income is above the budgeted amount for the year. Our expenses are below the budgeted amounts in each category.

Pat McCoy made a motion to approve the Financial Statement for the Fiscal Year 2023-2024 and Wendy Coker seconded the motion. The motion carried.

(4) Discussion on Money Market Account

Toni Wiersma discussed the possibility of opening a Money Market account for better interest rates than what is we are currently receiving on the checking account. Six checks could be written per month to transfer to the checking account. The interest rate quoted was 3.04%. The board felt that rate was low and directed Toni Wiersma to check other banks to see if we could get a better rate and check with SouthState bank to see if they would offer a better rate. The committee asked Toni Wiersma to check in to other banks as long as they were banks that provided security of the money.

Pat McCoy made a motion to have Toni Wiersma check other financial institutions and find the best rate and open a Money Market account. Dylan Tedders seconded the motion. The motion carried.

(5) Special Project Request

a) Healthy Start Baby Shower Request - \$2800.00.

A request was presented by Cassidy Medellin for \$2800.00 to help fund the annual Baby Shower for new mothers and infants. Last year 84 mothers attended the shower. The registration opened on April 22, 2024 and filled the same day with 104 registered parents. Healthy Start closed the registration because the room was at capacity. The Baby Shower will be held on May 17, 2024 at the IRSC Conference Center. Healthy Start purchases items such as pack-n-plays, strollers, car seats, diapers, and accessories for mom and babies. The Board complimented Healthy Start on the great job they are doing serving mom and babies. Bob McPartlan made a motion that Healthy Start be granted \$3500.00 for the project since more parents are attending the event and the need is greater. William Wallace seconded the motion. The motion carried.

6) Discussion on Our Village Request for audit requirement or exemption

During the March 21, 2024 meeting Mrs. Suarez had presented a letter requesting either an exemption from the audit requirement or funds to pay for an audit. The Board discussed that our Bylaws stated that an audit must be performed over any entity receiving more than \$25,000.00. Mrs. Suarez stated that she

had three different entities all under the umbrella of Our Village. Mrs. Suarez stated that she did have a firm that would perform an audit, if the Board required an audit, but she didn't have any funds to pay for the audit without cutting staff. Mrs. Wiersma, Executive Director, stated that in all of her projects funded by the Children's Services Council she did not have a line item for Administrative fees. Mrs. Suarez could submit a budget amendment of no more that 10% of the total budget for administrative cost and use that money to fund the audit. Mrs. Suarez was agreeable to this plan and would have an audit. Bob McPartlan made a motion that the Board follow the Bylaws and require an audit. Pat McCoy seconded the motion. The motion carried.

7) Monitors and Time for Mid-Year Review

Toni Wiersma reminded the Board that Mid-Year reviews were due and asked the Board to contact the various agencies.

8) Discussion on Summer Grant Funds

Discussion on how to distribute the funds for Summer Grants. In the past, 1/3 of the funds were dispersed at the beginning and the remainder of the funds were dispersed as receipts and invoices were received. The Board agreed that this was the practice and that funds should be dispersed in this way.

9) Results of Summer Grant Committee and Approval of Summer Grants

Toni Wiersma thanked the committee that served on the Summer Grant committee: Melisa Jahner, Daryl Roehm and Toni Wiersma. The Board reviewed the summer grant applications and noted that the total for summer grants was \$285,950.00 and the amount budgeted was \$271,364.00. Toni Wiersma reminded the Board that they would need to do a budget amendment if they approved all of the grants. Pat McCoy made the motion to approve all of the grants recommended by the committee. Bob McPartlan seconded the motion. The motion carried. See attached sheet

10) Open Discussion

- a) Executive Director Salary Melisa Jahner brought up the discussion of the Executive Director salary. In the past the Executive Director received \$2,200.00 per month and the secretary received \$2,000.00 per month. Currently the Executive Director is receiving \$30.00 per hour to exceed no more than 30 hours per week. Mrs. Wiersma is currently working about 20 hours per week completing both jobs. The Board discussed a salary position instead of an hourly salary. Bob McPartlan made a motion to place the Executive Director on a salary basis of \$3,500.00 per month. Bill Wallace seconded the motion. The change will be effective May 1, 2024. The motion carried.
- b) Budget Amendment for Summer Programs. Wendy Coker that a budget amendment of \$15,000.00 be made from the Reserve account to the Summer Program account. Bob McPartlan seconded the motion. The motion carried.
- c) Thank you note from the County Fair sent by Linda Syfrett for our continued support of the County Fair.
- d) The May meeting will need to be short because Scholarship Night begins at 6:00 PM.
- e) Heather Hancock mentioned that in June we need to discuss our policies on Special Projects.

f) Melisa Jahner informed the Board that we have several examples of a new logo for the Children's Services Council created by the Digital Design students. We will review them at the June meeting.

Motion made by Heather Hancock and seconded by Bob McPartlan to adjourn the meeting. The meeting was adjourned at 5:54 PM.
