- The Board discussed that Entities could apply for more than one Special Project.
- Our Bylaws regarding audits should be added to the bottom of the application form.

**WHEREAS**, the Children's Services Council of Okeechobee County, Florida on September 23, 2024, adopted Fiscal Year Final Millage Rates following a public hearing as required by Florida Statues 200.065.

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within Okeechobee County has been certified by the County Property Appraiser to the Children's Services Council of Okeechobee County as \$4;338,171,134.
