

Children's Services Council
1st Public Budget Hearing 2020-2021
Minutes
September 3, 2020

Ken Kenworthy called the Children's Services Council's 1st Public Budget Hearing to order at 5:09 p.m., at the Okeechobee County School Board, 700 S.W. 2nd Avenue, Room 303, with the following members present: Ken Kenworthy, Pat McCoy, Wendy Coker, Amanda Riedel, Heather Hancock (via ZOOM), and Cathleen Blair, Executive Director.

Cathleen Blair presented a millage rate of .3600 which is the same millage as 2019-2020. Wendy Coker made a motion to approve the millage rate of .3600, Amanda Riedel seconded, all approved.

Ken Kenworthy presented the following Tentative Budget using the millage rate of .3600 for 2020-2021. Using 95% collection of Taxable values, the projected ad valorem revenue is \$1,100,149, and an estimated Interest Income of \$5,000 and a Fund Balance of \$685,989 with all the projected expenses totaling \$1,016,062. Ken Kenworthy made a comment the reason the fund balance was so large is due to the COVID-19 pandemic. Amanda Riedel made a motion to tentatively approve the 2020-2021 budget as presented, Pat McCoy seconded, all approved.

The Minutes of July 9, 2020 were presented for approval. Pat McCoy made a motion to approve the Minutes as presented, Amanda Riedel seconded, all approved.

Cathleen Blair presented the Financial Statement for July 2020. Pat McCoy made a motion to approve as presented, Wendy Coker seconded, all approved.

Cathleen Blair presented a request for a budget amendment to the 2019-2020 budget. Recommend \$9,000 from Other Projects to Special Projects to cover additional expenses requested for other additional special projects that were approved. Pat McCoy, made a motion to approve the budget amendment, Wendy Coker seconded, all approved.
